

# Wedding Photography Agreement

## DESCRIPTION OF SERVICES

The parties agree that the Photographer will furnish photographic services on the above date, coverage to begin and end at a time mutually agreeable to the parties, details to be documented in the Photographer's Wedding Information Worksheet. The Photographer shall be the exclusive professional photographer retained by the Clients for the purpose of photographing the wedding. A professional photographer is defined as a photographer or other person, photographing with intent of selling images for monetary gain, and that any breach of this agreement will constitute a reason for non-completion of the job with no liability to photographer and loss of initial deposit by signing party.

Family and friends of the Clients are welcome to photograph the wedding as long as they shall not interfere with the Photographers' duties. The Photographer agrees to observe the customs of the particular House of Worship, photographing the ceremonies in a dignified, professional and unobtrusive manner.

## NO RAIN (OR SNOW) GUARANTEE

This is very simple. If it rains on your wedding day when we have outside photographs planned, we will be happy to schedule a photo session at your convenience anytime after the wedding. This will include up to one hour of time on-location. This agreement does not include transportation, tuxedo rental, floral arrangements, dress cleaning or rental.

#### PAYMENT POLICY

A Retainer of \$300 is required to hold your wedding date. Payments for additional items or coverages made prior to the wedding will be reserved and applied to the costs at the time of purchase. The price for this coverage is

## PRODUCT PRICING

Pricing is defined on the Photographer's standard price list in effect at the date of this contract. Prices quoted for professional services, photographs, and albums are guaranteed for a period of six months following the date of the wedding. Orders placed after six months following the wedding are billed at the rates in effect on the most recently published price lists.

#### ALBUM DESIGN

From the date of delivery of the images (or availability through online proofing) the bride and groom have 30 days to deliver a list of images they want in the album. After this time the bride and groom acknowledge that the Photographer reserves the right to design the albums as he sees fit.

#### COPYRIGHT & USAGE

The Photographer reserves the right to use the original digital files and/or reproductions for display, publication or other purposes without compensation. Original digital files remain the exclusive property of the Photographer. NOTICE OF COPYRIGHT: After Bride and Grooms albums are complete, Photographer and Clients will share copyright, high-resolution files will be turned over to Clients.



## LIMITATION OF LIABILITY

While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, the Photographer's entire liability to the Clients for any claim or loss arising from the Photographer's performance is limited to a refund to the Clients of the amount paid for services. In the unlikely event of personal illness or other circumstances beyond the control of the Photographer, a substitute photographer of high qualifications, subject to acceptance by the Client prior to the event, may be sent to fulfill the obligations of the Photographer herein contracted. In such case that the Client declines the substitute photographer, the Client may instead terminate this agreement and receive a full refund of all moneys paid. Because a wedding is an uncontrolled event, The Photographer cannot guarantee delivery of any specifically requested image(s). If a photo request list is provided for your photographer, please assign a friend or family member to introduce the persons on your list. It will be the Bride and Grooms responsibility to organize any groups for requested photographs. The Photographer will not be responsible for poses missed because of parties not being ready at the appointed hour, for glare and reflections from eyeglasses, for closed eyes or other matters beyond the control of the photographer.

# MONEY BACK GUARANTEE

If for any reason our clients are not satisfied with their purchase, they may return all products purchased within 30 days for a full refund. If for any reason our clients are not satisfied with their event coverage within 30 days of delivery of their paper proofs or availability of the online image gallery, they may return the proofs and receive a full refund. Once a full refund is received on event coverage, no orders for products or images relating to that event will be allowed.

## TERM/TERMINATION

This Agreement may be terminated by either party within 5 days of signing of this Agreement with written notice to the other party.

The Term of this Agreement is in effect for one year after signing of this Agreement by both parties.

## SEVERABILITY

If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

#### UPON SIGNATURE

The Photographer reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all paid retainer fees are non-refundable, even if date is changed or wedding canceled or postponed for any reason. If wedding date is postponed, canceled or rescheduled, The Photographer is released from the reserved date herein.

## AGREEMENT

This Agreement incorporates the entire understanding of the Parties, and the Parties agree to all its terms, and acknowledge receipt of a completed copy of the Agreement signed by all Parties. Any modifications of this Agreement must be in writing and signed by all parties. Each person signing as Clients(s) below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this agreement. This Agreement shall be governed by the laws of the District of Columbia.
